

- o Conservation Grant is meant for on-the-ground-work or outreach, but we need to clarify the language.
- o Motion by Bruce T. to approve the Research Grant application for Home Range Wildlife Research for \$2500 as presented to the WA-TWS Executive Board.
 - Jen S. seconds
 - No discussion
 - Vote in favor: 4, opposed: 1
 - Motion carries.
- o Motion by Jen to approve the Conservation Grant for \$2500 as presented to the WA-TWS Executive Board.
 - no seconds
 - no discussion, no vote
 - Motion fails.
- o Work next year on advertisement and language of what will be considered for Conservation Grant.
- 6. Scholarship
 - o Email vote to WA-TWS Executive Board.
 - o Bruce T. moves to approve the Scholarship Grant recipient as presented via email to the WA-TWS Executive Board.
 - Candace B. seconds
 - Vote in favor: 6, opposed: 0
 - Motion carries.
- 7. Incorporation
 - o What does this mean for our Chapter?
 - o We can discuss it with Ed Arnett at JAM 2023.
 - o Discuss further as an Executive Board after JAM 2023.
 - o December 2023 will need to be finalized.
- 8. WildApricot Subscription
 - o Our current subscription is for 2,000 contacts (Professional Level).
 - o Current subscription ends June 9, 2023.
 - We will need to renew for two years (2-year subscription lowers cost).
 - Move down to the lower subscriptions of 500 contacts (Community Level).
 - Only have WA-TWS members within WildApricot contacts, hold additional in spreadsheet and within MailChimp. Can add them back once we change subscriptions again.
 - o WildApricot price increase from \$3,400 to \$4,900/24 month cycle for the next cycle.
 - o Possible use of Donate Now, combination of other Chapters, or NW Section.
- 9. JAM 2024
 - o MOU approval is needed.
 - o 2024 JAM will be the last week of March with the Idaho Chapter.
 - o Provide comments back to George April 18th.
